DETAILS

Planning was granted on 9th September 2021 on land at Ham Farm, Gillingham, as part of the Gillingham Strategic Southern Expansion, comprising 961 units, a Local Centre providing retail, community, health and leisure purposes as well as ancillary works as part of the Strategic Southern Expansion as allocated in the North Dorset Local Plan 2016.

Phase 1A at Ham Farm comprises 205 units with 10% affordable housing.

The Principal Street has received HIF Funding and work has commenced with Access and Adoption Agreements in place.

The town of Gillingham provides a range of day to day facilities and amenities to include supermarkets, shops, nurseries & education and employment.

Gillingham has good transport links with a Mainline Railway station on the Exeter to London Waterloo line with London Waterloo accessible in under 2 hours. The local road network includes access to the A303 being 6 miles away and the A30 within 2 miles.


The selected party will be required to complete the Principal Street adjoining Shaftesbury Road and provide infrastructure without hinderance to the boundary of any future phases.
